SOIL POWERLINE 75W/80 GL-4 automotive type gear oils with medium EP feature, formulated to be used in automotive gearboxes operating at normal load and speed without excessive pressure and gear systems where oil at GL-4 level is recommended. It is easily used in gearboxes, differentials and other parts that require lubrication, operating under light, medium speed and load. It can also be used in gear systems that require GL-4 standard oil in cars, minibuses and light commercial vehicles using manual transmission.
